Joyous Giveaway Lucky Draw (Terms & Conditions)

The following terms and conditions (the “Terms and Conditions”) shall apply to Joyous Giveaway Lucky Draw (the “Lucky Draw”).

Eligibility for the Lucky Draw

1. The Lucky Draw is open to eligible members of the public who are at least twenty-one (21) years of age.
2. Employees of Resorts World at Sentosa Pte. Ltd. (“RWS”) and their immediate family members are not eligible to participate in the Lucky Draw.
3. RWS has the sole and absolute discretion to exclude any person from participating in the Lucky Draw.

Participation in the Joyous Giveaway Lucky Draw (from 7 December 2024 to 29 December 2024)

1. Eligibility for participation:
 - i. Every \$50.00 spending* in a single receipt at participating brands, at A Big Carnival of Joy at RWS entitles a shopper an entry into the Lucky Draw.
*Eligible spend between 7 to 15 December 2024 – Draw on 16 December 2024 (“Week 1”)
Eligible spend between 16 to 22 December 2024 – Draw on 23 December 2024 (“Week 2”)

 - ii. Eligible shopper will be given a draw entry slip during payment.
 - iii. Draw entry slip to be completed and dropped into designated draw boxes at either RWS Forum L1 or Forum B1 by eligible shopper who wishes to participate in the Lucky Draw i.e. Participant.
 - iv. Cut-Off Time for each week’s Lucky Draw will be on Sundays (15, 22, and 29 December 2024) SGT 10:00PM.

Conduct of Lucky Draw & Prizes

1. Joyous Giveaway Lucky Draw
 - i. The Lucky Draw will be conducted on 16, 23 and 30 December 2024.

 - iii. Each weekly winner announcement will be made via RWS Instagram Story and RWS website, and in RWS – Whimsical Timekeeper, Cuckoo Clock Display on Tuesdays 17, 24, 31 December 2024, SGT 6:00PM.
 - iv. Winners will also be notified by email as per the email address stated in the draw entry slip.
 - v. Results of the Lucky Draw will be pinned on RWS’s Instagram Profile and RWS website for a minimum of 2 months from 17 December 2024 to 28 February 2025.

2. Prizes

10. A person who is not a party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act 2001 to enforce any of these Terms and Conditions.
11. In the event of a dispute between the English version and the other versions of the Terms and Conditions, the English version shall prevail.
12. The Terms and Conditions shall be governed by and interpreted in accordance with Singapore law. The Courts of Singapore shall have exclusive jurisdiction over any disputes arising from these Terms and Conditions, including the validity and enforceability thereof.
