Terms and Conditions Governing the "What's Your Favourite Moment" Contest

The following terms and conditions (the "Terms") shall apply to the S.E.A. Aquarium "What's Your Favourite Moment" Contest organized by Resorts World at Sentosa Pte. Ltd. ("RWS") (the "Contest").

Eligibility

- 1. This Contest is open to all members of the public ("**Participants**") who are at least eighteen (18) years of age.
- 2. Participants may be required to present valid government-issued identification for verification of identity and age upon request.
- 3. Directors, officers and employees of the following entities and each of their immediate family members (ie parents, grandparents, spouses, siblings, children and grandchildren) are not eligible to participate in the Contest:
 - a. RWS and entities within the Genting Group;
 - b. RWS partners and/or sponsors and/or merchants and/or external auditors participating in the Contest;
 - c. RWS' advertising agencies.
- 4. RWS has the sole and absolute discretion to exclude any person from participating in the Contest (including but not limited to a person who fails to provide true, correct, complete and accurate information) without any obligation to furnish any notice and/or reason.

Duration of the Contest

Participation Mechanics

 - b. Follow and tag @s.e.a.aquarium on their posts

(the "Contest Entry")

- 7. Participants may submit more than one Contest Entry, but each Participant shall be limited to winning a maximum of one (1) Prize each.
- 8. Participants must have their social media account/post privacy setting set as "public" during the Contest Period.
- 9. RWS reserves the right to change or amend the details and/or mechanics of the Contest, at its sole and absolute discretion.

Contest Mechanics

10. The seven (7) most creative submissions as deemed by RWS, shall be selected as winners.

11. The seven (7) unique winners will be selected from the Participants, with each Participant only eligible to be selected once.

Prizes

- 12. There will be a total of seven (7) prizes, each prize comprising of Genshin Impact Chibi acrylic ornament, t-shirt, thermos and canvas tote bag ("**Prizes**"), with one (1) of every item given to each unique winner.
- 13. The Prizes will be issued during an onsite collection to be arranged at the S.E.A. Aquarium.

Collection of Prizes

- 14. The winners will be announced via Instagram story weekly and contacted via direct messaging. RWS will request for winners to provide their Full Name, Email Address and Contact Number for prize redemption.
- 15. RWS will carry out a verification process to verify the winners' identities. Upon successful verification, winners will receive an email containing instructions relating to the prize collection process ("Redemption Email").
- 16. All Prizes are to be redeemed within 1 month of issuance of the Redemption Email. Any unclaimed prizes will be forfeited.
- 17. All Prizes must be collected in person with the winner's proof of his or her Instagram account and Redemption Email.
- 18. Winners will have to sign a prize verification form ("**Prize Verification Form**") upon receiving their Prizes to acknowledge that they have received their Prize from RWS.
- 19. During the selection, RWS reserves the right to choose a number of "reserve winners" to replace any winner subsequently disqualified. The number of "reserve winners" and manner of replacement of winners will be made at RWS's sole and absolute discretion.

RWS Restricted

- 3. Any Participants found cheating will be disqualified from the Contest and rendered ineligible to win the Prizes. RWS reserves the right to disqualify any Participants from the Contest for fraud, manipulation or other related issues, including providing false information (such as fake account(s), personas or photos) or for deliberately withholding information.
- 4. By participating in the Contest, all Participants agree and shall be deemed to have agreed to participate in any publicity, advertisement or media coverage as requested or required by RWS, without compensation. - 5. RWS reserves the right to change, suspend, withdraw or cancel the Contest and to amend these Terms at any time in its sole discretion without giving prior notice to the Participants. The decision of RWS on all matters relating to or in connection with the Contest is final, and no correspondence will be entertained.
- 6. The Participant shall fully indemnify and hold RWS harmless from and against any loss, damage, cost, liability, or expense (including legal fees), whether direct or indirect, which RWS may incur arising out of or in connection with the Participant's breach of these Terms.
- 7. The Participant hereby grants his/her consent to RWS to collect, use and disclose the Participant's personal data acquired, for the following and/or other reasonable purposes in accordance with RWS' Personal Data Protection Statement (available at RWS's website https://www.rwsentosa.com/en/personal-data-protection):
 - a. administering this Contest, including to contact you for the administration of the prize in relation to this Contest;
 - b. verifying your identity;
 - c. responding to, handling, and processing queries, requests, applications, complaint and feedback from you;
 - d. managing your relationship with us;
 - e. complying with any applicable laws, regulations, codes of practice, guidelines, or rules, or to assist in law enforcement and investigations conducted by any governmental and/or regulatory authority:
 - f. any other purposes for which you have provided the information:
 - g. transmitting to any unaffiliated third parties including our third party service providers and agents, and relevant governmental and/or regulatory authorities, whether in Singapore or abroad, for the aforementioned purposes; and
 - h. any other incidental business purposes related to or in connection with the above.
- 8. A person who is not a party to any agreement governed by these Terms shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B), including but not limited to the enforcement of any of these Terms.
- 9. In the event of any inconsistencies or discrepancies between the Terms and the contents of any brochure, marketing and/or promotional materials relating to the Contest, these Terms shall prevail.
- 10. In the event of inconsistency or discrepancy between the English version and the other versions of the Terms, the English version shall prevail.
- 11. The Terms shall be governed by and interpreted in accordance with Singapore law without regard to its principles of conflicts of laws. The Courts of Singapore shall have exclusive jurisdiction over any disputes arising from these Terms, including the validity and enforceability thereof.
